Move out Notice

Dear Exhibitors,

productronica China 2024 will be concluded at 16:00,22 March. Please be sure that all move-out works will be conducted strictly as the follow move-out schedule arranged by organizer.

A. Time schedule: 22 March, 2024

Please apply "Waiting Permit" online and enter P3/P7 under guidance and then buy truck entry pass (P7/P3/Certification Center in South entrance), please arrange your truck get into the fair ground parking area as early as possible to avoid long time queuing.

- a. 16:00 hand carried exhibits move out (please submit exhibits registration form to APT Showfreight Shanghai Co., Ltd at Loading Bay outside Gate 4 of Hall E2,E4,E6.
- b. 16:00 water、 power supply、air compressor cut off . Please turn off all electrical equipments and machines in advance. If you need overtime power supply, please apply from related <u>Official Contractor Counter C3.3249</u> before <u>12:00 on 22 March.</u>
- c. 16:00-24:00 booth dismantling. ***If you need overtime work for dismantling, Please apply from <u>Customer Service</u> <u>Center in 1# South entrance hall</u> before 12:00 on 22 March.**

B. Important notice for the entry of freight vehicles and exhibit vehicles

According to the newest regulations of Shanghai New International Expo Centre, the queue management of vehicles will be implemented from now on. A "Waiting Permit" is required for each freight vehicle / exhibit vehicle that needs to enter the venue, which must be applied in advance through online system with the completion of vehicle registration and payment. The system-generated "Waiting Permit" shall be printed on A4 paper and placed on the front windshield of the vehicle, so that it enters the designated parking lot for a specified period of time. Vehicles not showing the "Waiting Permit" or not complying with the specified period of time on "Waiting Permit" are not allowed to enter or park in the surrounding area of Shanghai New International Expo Center (ie Middle Yanggao Road - Luoshan Road - Longyang Road - Pujian Road - South Yanggao Road), otherwise it will be regarded as in violation of traffic rules. For details, please consult the official contractor / freight forwarder.

According to the latest regulations of SNIEC, all vehicles entering the loading bay of the venue need to register the driver and vehicle related information in advance through the wechat Official Account of the hall owner (SNIEC) and go to the SNIEC certification center to apply for the vehicle license of the loading bay with the registered QR code. For specific procedures, please refer to the attachment "Application and Handling Process for Unloading Area Vehicle License and Q&A".

- The freight vehicle must enter the surrounding area of the venue with showing the "Waiting Permit" processed online in advance, and then is admitted in the loading bay with the "vehicle permit to loading bay".

- Each mobile phone number / each license plate number can only be used to register one "Waiting Permit" per day. The license plate number can be modified several times before payment but once only after payment. The vehicle is not allowed to enter the parking lot of the venue if it does not comply with the "Waiting Permit".
- In case of failure to arrive at the designated parking lot within the specified period of the "Waiting Permit", the vehicle may only be delayed one batch later in the day.
- For the "Waiting Permit" fee, an electronic invoice can be issued temporarily, which can be viewed through online system and printed on your own. It is subject to the approval of the Tax Bureau.
- The driver should follow the guidance of the security guard and is forbidden to leave the vehicle unattended. Once the loading and unloading is finished, the vehicle shall be driven out immediately to avoid unnecessary traffic jam for which the deposit will be deducted as a penalty.
- The overtime charge will be levied at RMB 100 per vehicle per every half hour (the overtime charge for less than half an hour is also RMB 100).
- The deposit will be refund with showing the "Vehicle Permit to Loading Bay" as well as the deposit receipt within 10 days after the completion of the loading and unloading only. For any loss or damage of the "Vehicle Permit to Loading Bay", the deposit will not be refunded.
- > The above fees are not inclusive of overnight parking fees.
- C. Important notice:
- a. All hand carried exhibits are allowed to be moved out with showing the exhibits registration form issued by Official forwarder please submit exhibits registration form to **APT Showfreight Shanghai Co.**, **Ltd** at Loading Bay **outside Gate 4 of Hall E2,E4,E6**. All trolleys can be transported only by small entrance of loading bay. No goods are allowed to be transported through entrance hall. The gate of loading bay will be opened after 16:00. All trucks drive into loading bay need to show truck entry pass from SNIEC office located in the south entrance Certification Center.
- b. All power supply will be cut off at 16:00 on 22 March. Please turn off all electrical equipments and machines and exam all facilities in advance. If you need power supply after 16:00, please apply from related <u>Official Contractor Counter</u> C3.3249 Viewshop before 12:00 on 22 March.
- c. All booth dismantling will start from 16:00 on 22 March Any dismantling with electricity before 16:00 is strictly forbidden. All exhibits and construction materials cannot be moved out before 16:00. All constructing materials such as abandon wood and wires should be cleared out by exhibitors or contractors before 22:00 on 22 March.
- d. The hanging banners and hanging structures will be dismantled on 22 March after 20: 00.

e. **Please pay great attention to your exhibits and personal belongings. The organizer will not be responsible for any loss.** f. **For raw space booth getting back build-up deposit**, please go to Gate 1 to call hall staff exam the dismantled booth and confirm there is no destroy. The general management deposit will be returned by transfer. The exhibitor/contractor is required to provide the relative information concerning company name, bank name, A/C No. (in accordance with the account info when transferring), remittee's name and contact details when he applies for the refund of deposit at Official Contractor onsite service counter. It will take 30 working days to complete the refund after the show.

It is strongly advised to employ the service of the official freight forwarder than the other ones to avoid any unnecessary losses.

Finally, please pay attention to the safety of booth dismantling. Safe belt and helmet should be used when dismantling. <u>Aiding information:</u> In serious cases: call the ambulance: 120
